## Ordinance.910

Lateral Entry: For Lateral entry into M.C.A. IIIrd Semester eligibility is as per DTE (Director of Technical Education) guidelines i.e. candidate who have passed Bachelor of computer application (B.C.A., ) Bachelor of Computer Science B.Sc. Computer Science B.Sc. (I.T.) are eligible to be admitted to M.C.A. IIIrd semester. Such candidate shall be exempted from appearance in M.C.A. Ist & IInd semester examination. For calculation of equivalent of M.C.A. Ist & IInd sem. Examination their aggregate percentage should be converted and made equal to 1000 marks.
