Sir,

With reference to your application dated 7-3-2001 for the post of Reader in the subject of Environmental Science in the University Department of Environmental Science and further to the interview you had with us on 8-9-2001, I am directed to inform you that the Hon'ble Vice-Chancellor, in exercise of the powers, conferred upon him under Section 14(9) of the Maharashtra Universities Act, 1994, is pleased to appoint you as Reader in the University Department of Environmental Science, in the pay scale of Rs.12000-420-18300, plus other allowances admissible under the existing rules. and, as may be revised from time to time, by the Government on the following terms and conditions.

- 1) Your appointment is against the post reserved for Scheduled Caste category and is on a purely temporary basis.
- 2) Your services shall be governed by the Maharashtra Universities Act, 1994, in force for the time being and that may be amended from time to time, and the Statutes, Ordinances, the Rules and Regulations made thereunder and, in force for the time being and that may be amended from time to time,
- 3) The terms and conditions of your appointment as a Reader in Environmental Science shall be subject to the directions, orders, instructions etc. that may be issued/given by the Maharashtra State Government and U.G.C., from time to time, and the service contract shall stand modified/alterd to that extent accordingly,
- 4) Your appointment on the said post is on a purely temporary basis, subject to the decision of the Caste Validity Committee, as laid down in clause 9, of the Government Resolution No. CBC-12-2000/ 252/CN-1/BC-5, dated 25-1-2000 and hence, your appointment will automatically come to an end, if the Caste Validity Committee rejects your claim to be belonging to Scheduled Caste category.
- 5) Your services shall come to an end automatically, if the antecedent report from the police authority is not found satisfactory.
- 5) You will have to undergo a medical test at the University Health Center. If the medical report from the Medical Officer of the Health Center of the University is not found satisfactory, your appointment shall come to an end automatically.
- 6) The fixation of your pay in the above pay-scale shall be made after receipt of your last pay certificate from the College where you are presently working and subject to the approval by the Joint Director (Higher Education), Aurangabad Region, Aurangabad, and will be communicated to you lateron.
- 7) You will have to submit the original Service Book from your present college, duly completed in all respects i.e. the date of your leaving the institution and such other relevant information within a period of one month from the date of joining the duties.
- 8) The original fixation sheet duly approved by the concerned Joint Director (Higher Education) should invariably accompany the Service Book.


Sir,
