- If applicable, you will have to submit the original Service Book from your present employer, duly completed in all respects i.e. the date of your leaving the institution and such other relevant information within a period of one month from the date of joining the duties.
- 9] If applicable the original fixation sheet duly approved by the concerned Joint Director (Higher Education) should invariably accompany the Service Book.
- At the time of joining the duties you will have to submit attested xerox copies of all the testimonials for record of the office and will have to produce original testimonials for verification.
- You will also enter into the service contract with the University that shall govern the terms and conditions and the university may prescribe conditions of your service inclusive of above mentioned conditions and such other conditions, in this regard.
- 12] You are required to submit, while joining the duties, the discharge or relieving certificate alongwith last pay certificate from your present employer, if any.

If these terms and conditions are acceptable to you, you are requested to communicate your acceptance to the University in the format enclosed herewith and report for duty to the Professor and Head, Department of Botany, Dr. Babasaheb Ambedkar Marathwada University, Aurangabad, within a period of one month from the date of receipt of this appointment order.
