- 5] You will have to undergo a medical test at the University Health Centre. If the medical report from the Medical Officer of the Health Centre of the University is not found satisfactory, your appointment shall come to an end automatically.
- 6] If applicable, the fixation of your pay in the above pay-scale shall be made after receipt of your last pay certificate from the present employer and subject to the approval by the Joint Director (Higher Education), Aurangabad Region, Aurangabad, and will be communicated to you lateron,
