I am directed to inform you that, the Hon'ble Vice-Chancellor, in exercise of the powers, conferred upon him under Section 14 (9) of the Maharashtra Universities Act, 1994, is pleased to appoint you on the **substantive post of Assistant Professor** in the subject of **Bio-Chemistry** in the Department of **Bio-Chemistry** in the pay band of **Rs. 15600-39100 (AGP Rs. 6000/-) (Revised)** plus other allowances admissible under the existing rules and as may be revised from time to time, by the Government / UGC on the following terms and conditions.

- 1] Your appointment is for **Open Category** on Probation for a period of One Year from 01-04-2012.
- 2] You will receive allowances as per prevailing rules.
- 3] Your services will be governed by the Maharashtra Universities Act, 1994, Statutes, Ordinances, Regulations, Rules made there under for the time being in force and as may be amended or modified from time to time. Orders of the competent authorities issued from time to time shall also be binding on you.
- 4] If applicable, Newly Government introduced **Defined Contribution Pension Scheme** will be made applicable to you.



- 5] The terms and conditions of your appointment as a **Assistant Professor** in **Bio-Chemistry** shall be subject to the directions, orders, instructions etc. that may be issued/given by the Maharashtra State Government and U.G.C., from time to time, and the service contract shall stand modified/alterd to that extent accordingly,
- 6] If applicable, the fixation of your pay in the above pay-scale shall be made after receipt of your last pay certificate from the parent institution and will be made applicable subject to the approval by the Competent Government Offices and will be communicated to you lateron.
- 7] If applicable, you will have to submit the original Service Book from parent institution duly completed in all respects i.e. the date of your leaving the institution and such other relevant information within a period of one month from the date of joining the duties.
- 8] The original fixation sheet of VIth pay commission duly approved by the concerned Joint Director (Higher Education) should invariably accompany the Service Book.
- 9] You will also enter into the service contract with the University that shall govern the terms and conditions and the university may prescribe conditions of your service inclusive of above mentioned conditions and such other conditions, in this regard.
- 10] If applicable, the previous service will be counted with the prior approval of Regional Joint Director, Higher Education for academic and DCPS/Pension purpose.

If these terms and conditions are acceptable to you, you are requested to communicate your acceptance to the University in the format enclosed herewith and report for duty to the Professor & Head, Department of Bio-Chemistry, Dr. Babasaheb Ambedkar Marathwada University, Aurangabad, within a period of one month from the date of receipt of this appointment order.
