With reference to your application dated 19-08-2004 for the post of Lecturer in the subject of English in the University Department of English and further to the interview you had with us on 20-06-2005, I am directed to inform you that the Hon'ble Vice-Chancellor, in exercise of the powers, conferred upon him under Section 14(9) of the Maharashtra Universities Act, 1994, is pleased to appoint you as Lecturer in the University Department of English, in the pay scale of Rs. 8000-275-13500, plus other allowances admissible under the existing rules. and as may be revised from time to time, by the Government on the following terms and conditions.

- 1] Your appointment is against the post reserved for Scheduled Tribes category and is on probation for a period of two years.
- 2] Your services shall be governed by the Maharashtra Universities Act, 1994, in force for the time being and that may be amended from time to time, and the Statutes, Ordinances, the Rules and Regulations made there under and, in force for the time being and that may be amended from time to time,
- 3] The terms and conditions of your appointment as a Lecturer in English shall be subject to the directions, orders, instructions etc. that may be issued/given by the Maharashtra State Government and U.G.C., from time to time, and the service contract shall stand modified/alterd to that extent accordingly,
- 4] Your services shall come to an end automatically, if the antecedent report from the police authority is not found satisfactory.
- 5] You will have to undergo a medical test at the University Health Centre. If the medical report from the Medical Officer of the Health Centre of the University is not found satisfactory, your appointment shall come to an end automatically.
- 6] The fixation of your pay in the above pay-scale shall be made after receipt of your last pay certificate from the College where you are presently
