- 2] Your appointment on the said post is purely on a temporary on contract basis for a period of two years from the date of joining in accordance with Higher & Technical Education Department Mantralaya, Mumbai G.R. No. संकीर्ण - २००३ / १४३ / विशि-४, दिनांक २३-०१-२००४. You will not be entitled to receive any other permanency benefits, which are applicable and available to the permanent teachers.
- 3] Your services shall be governed by the Maharashtra Universities Act, 1994, in force for the time being and that may be amended from time to time, and the Statutes, Ordinances, the Rules and Regulations made there under and, in force for the time being and that may be amended from time to time,
- 4] The terms and conditions of your appointment as a **Lecturer** in the subject of **Master of Computer Application** shall be subject to the directions, orders, instructions etc. that may be issued/given by the Maharashtra State Government and U.G.C., from time to time.




- 5] Your services shall come to an end automatically, if the antecedent report from the police authority is not found satisfactory.
- 6] You will have to undergo a medical test at the University Health Centre. If the medical report from the Medical Officer of the Health Centre of the University is not found satisfactory, your appointment shall come to an end automatically.
- 7] At the time of joining the duties, you will have to submit attested xerox copies of all the testimonials including Caste Validity Certificate issued by competent authority for record of the office and will have to produce original testimonials for verification.
