With reference to the interview you had with us on 24-09-2009 for the post of **Lecturer** in the subject of **Master of Business Administration (MBA) Course** I am directed to inform you that the Hon'ble Vice-Chancellor, in exercise of the powers, conferred upon him under Section 14(9) of the Maharashtra Universities Act, 1994, is pleased to appoint you as **Lecturer** in the subject of **Master of Business Administration (MBA) Course** in the pay scale of Rs. 8000-275-13500.

- 1] Your appointment is for **Other Backward Class Category**.
- 2] Your appointment on the said post is purely on a temporary on contract basis for a period of **five years** from the date of joining. After which your services will be automatically come to end. You will not be entitled to receive any other permanency benefits, which are applicable and available to the permanent teachers.
- 3] Your services are transferable.
- 4] Your services may be terminated at any time by giving a notice of one month or one month's salary in lieu of such notice and without assigning any reason thereof and vice versa.
- 5] Your services will be governed by the Maharashtra Universities Act, 1994, Statutes, Ordinances, Regulations, Rules made there under for the time being in force and as may be amended or modified from time to time. Orders of the competent authorities issued from time to time shall also be binding on you.
- 6] At the time of joining the duties, you will have to submit attested photocopies of all the testimonials for record of the office and will have to produce original testimonials for verification.
- 7] You will submit your joining report (four copies) in the enclosed proforma through proper channel.
