With reference to your application dated 14-09-2005 for the post of Lecturer in the subject of Computer Science and Information Technology in the Dr. Babasaheb Ambedkar Marathwada University, Aurangabad and further to the interview you had with us on 03-12-2005, I am directed to inform you that the Hon'ble Vice-Chancellor, in exercise of the powers, conferred upon him under Section 14(9) of the Maharashtra Universities Act, 1994, is pleased to appoint you as Lecturer on consolidated salary of Rs. 8000/- per month.

- 1] Your appointment is on the post for Open Category.
- 2] Your appointment on the said post is purely on a temporary on contract basis for a period of one year from the date of joining. (This post is created through University fund.) You will not be entitled to receive any other permanency benefits, which are applicable and available to the permanent teachers.
- 3] Your services shall be governed by the Maharashtra Universities Act, 1994, in force for the time being and that may be amended from time to time, and the Statutes, Ordinances, the Rules and Regulations made there under and, in force for the time being and that may be amended from time to time.
- 4] The terms and conditions of your appointment as a Lecturer in Computer Science and Information Technology shall be subject to the directions, orders, instructions etc. that may be issued/given by the Maharashtra State Government and U.G.C., from time to time.
- 5] Your services shall come to an end automatically, if the antecedent report from the police authority is not found satisfactory.
- 6] You will have to undergo a medical test at the University Health Centre. If the medical report from the Medical Officer of the Health Centre of the University is not found satisfactory, your appointment shall come to an end automatically.
- 7] If applicable, the fixation of your pay in the above pay scale shall be made after receipt of your last pay certificate from the present employer and subject to the approval by the Joint Director, Aurangabad.
