With reference to your application dated 19-09-2006 for the post of Lecturer in the Department of Fine Art in the Dr. Babasaheb Ambedkar Marathwada University, Aurangabad and further to the interview you had with us on 14-03-2007, I am directed to inform you that the Hon'ble Vice-Chancellor, in exercise of the powers, conferred upon him under Section 14(9) of the Maharashtra Universities Act, 1994, is pleased to appoint you as Lecturer in the pay scale of Rs. 8000-275-13500 plus other allowances admissible under the existing rules. and as may be revised from time to time, by the Government on the following terms and conditions.

- 1] Your appointment is for the post for Open Category on purely temporary basis.
- 2] Your appointment on the said post is on purely temporary on a contract for a period of five years from the date of joining (This post is created from University Funds). You will not be entitled to receive any other permanency benefits which are applicable & available to the permanent teachers.
- 3] Your services shall be governed by the Maharashtra Universities Act, 1994, in force for the time being and that may be amended from time to time, and the Statutes, Ordinances, the Rules and Regulations made there under and, in force for the time being and that may be amended from time to time,
- 4] The terms and conditions of your appointment as a Lecturer in Fine Art shall be subject to the directions, orders, instructions etc. that may be issued/given by the Maharashtra State Government and U.G.C., from time to time.
- 5] Your services shall come to an end automatically, if the antecedent report from the police authority is not found satisfactory.
- 6] You will have to undergo a medical test at the University Health Centre. If the medical report from the Medical Officer of the Health Centre of the University is not found satisfactory, your appointment shall come to an end automatically.
- 7] If applicable, the fixation of your pay in the above pay-scale shall be made after receipt of your last pay certificate from the present employer and subject to the approval by the Joint Director (Higher Education), Aurangabad Region, Aurangabad, and will be communicated to you lateron,
- 8] If applicable you will have to submit the original Service Book from your present employer, duly completed in all respects i.e. the date of your leaving the institution and such other relevant information within a period of one month from the date of joining the duties.
