
With reference to your application, I am to inform you that as per provisions of the Maharashtra Universities Act, Statutes and Ordinances, the Hon'ble Vice-Chancellor on the recommendations made by the constituted Selection Committee, has been pleased to appoint you, as per terms and conditions mentioned herebelow, to the post of LECTURER in the University School of CHEMICAL SCIENCES with immediate effect on a starting basic pay of Rs.2200/- p.m. in the time scale of pay of Rs.2200-75-2800-100-4000 plus usual allowances (Dearness Allowances and House Rent Allowances) permissible under the Government rules.

2. You may kindly note that your appointment is :-
- ✓ i) on probation for a period of two years from the date of your joining.
 - ~~ii) purely on a temporary basis for one academic year U/S 77 of Maharashtra Universities Act, 1994.~~
 - ~~iii) purely on a temporary basis for the academic year 1999-2000 and is against the post of~~
 - ~~iv) against Lien vacancy and is likely to be continued.~~

Your services are liable to be terminated/discontinued at any time by giving one month's notice on either side and/or by payment of one month's pay in lieu of notice without any reason being assigned for such discontinuation/termination of your services.

3. Please also note that the conditions of service, leave rules and conduct, discipline and appeal rules as are prescribed and will be prescribed hereinafter by the Statutes will be binding upon you. The provisions of the Maharashtra Universities Act, 1994, and the statutes, ordinances, regulations, rules and orders thereunder shall also be binding upon you.
4. You are also expected to submit through proper channel six monthly assessment report during the period of your tenure as LECTURER, as and when the same becomes due. You are also required to enter into an agreement with the University that shall govern the conditions of your service inclusive of above mentioned conditions, and such other conditions as may be laid down by the University, from time to time.
5. You are also required to submit, while joining the duties, the discharge or relieving certificate alongwith last pay certificate from your present employer, if any, and will have to give an undertaking in the prescribed form before joining the duties.
6. Please submit your acceptance letter so as to reach the University on or before 30.06.1999 positively, failing which it will be assumed that you are not interested in this appointment and your appointment is liable to be cancelled and/or withdrawn.

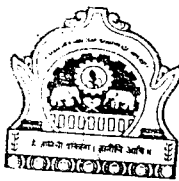

In continuation of this office letter No. ESTT/DEPT/2002/15491-92, dated 12/13-2-2002, I am directed to inform you that, consequent upon the receipt of your Caste Validity Certificate dated 5-4-2002, from the Member, Divisional Caste Certificate Verifying Committee, Nasik Division, Nasik the Hon'ble Vice-Chancellor, in exercise of the powers, conferred upon him under Section 14(9) of the Maharashtra Universities Act, 1994, is therefore, pleased to appoint you as Lecturer in the University Department of Chemistry, in the pay scale of Rs.8000-275-13500 plus other allowances admissible under the existing rules, and as may be revised from time to time, by the Government on the following terms and conditions.

- 1) Your appointment is against the post reserved for VJ (A) (internally transferable amongst N.T.(B), N.T.(C) & N.T.(D) category on probation for a period of two years from the date of your joining the duties.
- 2) Your services shall be governed by the Maharashtra Universities Act, 1994, and that may be amended from time to time, and the Statutes, Ordinances, the Rules and Regulations made there under and, in force for the time being, and that may be amended from time to time.
- 3) The terms and conditions of your appointment as a Lecturer in Chemistry shall be subject to the directions, orders, instructions etc. that may be issued/given by the Maharashtra State Government and U.G.C., from time to time, and the service contract shall stand modified/alterd to that extent accordingly.
- 4) Your services shall come to an end automatically, if the antecedent report from the police authority is not found satisfactory.
- 5) You will have to undergo a medical test at the University Health Center. If the medical report from the Medical Officer of the Health Center of the University is not found satisfactory, your appointment shall come to an end automatically.
- 6) The fixation of your pay in the above pay-scale shall be made after receipt of your last pay certificate from the College where you are presently working and subject to the approval by the Joint Director (Higher Education), Aurangabad Region, Aurangabad and will be communicated to you lateron.
