With reference to the interview dated 14-08-2013 for the post of Associate Professor in the subject of English and further to the interview you had with us on 14-08-2013, in response to the Advt. ESTT/DEPT/98/2013 dated 04-06-2013. I am directed to inform you that the Hon'ble Vice-Chancellor, in exercise of the powers, conferred upon him under Section 14 (9) of the Maharashtra Universities Act, 1994, is pleased to appoint you as Associate Professor for Lien Vacancy in the pay scale of Rs. 37400-67000 AGP Rs. 9000/- plus other allowances admissible under the existing rules and as may be revised from time to time, by the Government on the following terms and conditions.

- 1] Your appointment is for the post reserved for **Scheduled Caste Category** and is on Lien Vacancy. The period of appointment shall be till the teacher on Lien rejoins back. The appointment shall not be continued as regular appointment in the light of Government of Maharashtra Department of Higher & Technical Education, Resolution dated 23-08-2010.
  - 2] Your services shall be governed by the Maharashtra Universities Act, 1994, in force for the time being and that may be amended from time to time, and the Statutes, Ordinances, the Rules and Regulations made there under and, in force for the time being and that may be amended from time to time,
  - 3] Previous Government Pension Scheme and GPF scheme if applicable to you will be made applicable subject to approval of Joint Director (Higher Education), Aurangabad Region, Aurangabad.
  - 4] The terms and conditions of your appointment as a **Associate Professor in English** shall be subject to the directions, orders, instructions etc. that may be issued/given by the Maharashtra State Government and U.G.C., from time to time.
  - 5] Your services shall come to an end automatically, if the antecedent report from the police authority is not found satisfactory.

- 6] You will have to undergo a medical test at the University Health Centre. If the medical report from the Medical Officer of the Health Centre of the University is not found satisfactory, your appointment shall come to an end automatically.
- 7] If applicable, the fixation of your pay in the above pay-scale shall be made after receipt of your last pay certificate from the parent institution and will be made applicable subject to the approval by the Competent Government Offices and will be communicated to you lateron.
- 8] If applicable, you will have to submit the original Service Book from parent institution duly completed in all respects i.e. the date of your leaving the institution and such other relevant information within a period of one month from the date of joining the duties.
- 9] The original fixation sheet duly approved by the concerned Joint Director (Higher Education) should invariably accompany the Service Book.
- 10] At the time of joining the duties you will have to submit attested photo copies of all the testimonials for record of the office and will have to produce original testimonials for verification.
- 11] You will submit, while joining the duties, the discharge or relieving certificate alongwith last pay certificate from your present employer, if any.

If these terms and conditions are acceptable to you, you are requested to communicate your acceptance to the University in the format enclosed herewith and report for duty to the Professor & Head, Department of **English**, Dr. Babasaheb Ambedkar Marathwada University, Aurangabad, within a period of one month from the date of receipt of this appointment order.


Sir,

With reference to the above subject and reference I state that I have been appointed as Associate Professor, Department of English, as per the Advertisement No. Advt./ESTT/DEPT/98/2013 dated 04/06/2013 and the subsequent interviews on 14<sup>th</sup> August 2013. Accordingly I joined the services of the University on 13<sup>th</sup> September, 2013.

However, contrary to the information that I have, my appointment letter states that the vacancy I have been appointed on is a lien vacancy I may add that to the best of my information the lien period of Dr. Vaishali Pradhan who was the previous incumbent on the post expired on April 1, 2013, i.e. at least three months before the relevant advertisement which was published on 04/06/2013.

In the light of the above facts I request you to issue me a fresh and regular appointment letter deleting the references to the lien vacancy and the Government Resolution dated 23/08/2010. I may further add that there are no other issues involved since the post is reserved for the SC Category to which I belong.
