In continuation of this office letters No. ESTT/DEPT/2004/9030-33, dated 01-11-2004 and No ESIT/DEPT/2006/19691-96, dated 05-09-2005, I am directed to inform you that the Hon'ble Vice-Chancellor, by virtue of the powers conferred upon him under the provision of Section 14(9) of the Maharashtra Universities Act, 1994, is pleased to revise and regularize your appointment as Lecturer in the subject of Education in the pay scale of Rs. 8000-275-13500, plus other allowances admissible under the existing rules and as may be revised from time to time, by the Government on the following terms and conditions.

- 1] Your appointment is for Open category and is on a probation for a period of two years with effect from 22-11-2004 i.e. the date of your joining the Government approved post of Lecturer in the Department of Education at the Dr. Babasaheb Ambedkar Marathwada University sub-centre at Osmanabad .
- 2] Your services shall be governed by the Maharashtra Universities Act, 1994, in force for the time being and that may be amended from time to time, and the Statutes, Ordinances, the Rules and Regulations made there under and, in force for the time being and that may be amended from time to time,
- 3] The terms and conditions of your appointment as a Lecturer in Education shall be subject to the directions, orders, instructions etc. that may be issued / given by the Maharashtra State Government and U.G.C., from time to time, and the service contract shall stand modified/alterd to that extent accordingly,
- 4] You will also enter into the service contract with the University that shall govern the terms and conditions and the University may prescribe conditions of your service inclusive of above mentioned conditions and such other conditions, in this regard.
- 5] If applicable the fixation of your pay in the above pay-scale shall be made subject to the approval by the Joint Director (Higher Education), Aurangabad Region, Aurangabad, and will be communicated to you lateron,
