With reference to your proposal for Minor Research Project entitled "Synthesis anticancer and antimicrobial activities of new pyridinyl and thiazolyl bearing hybrid scaffolds" the University authorities have considered the said application and sanctioned you a grant of Rs.1,50,000/- (Rs. 
The said grant will be paid to you in two installments. The first installment (Approx. 50%) will be paid to you soon after the acceptance of all conditions attached to the Grants. The last installment will be paid after final report is submitted by you along with the statement of accounts supported by the vouchers and return of materials such as books, equipment's etc if any purchased out of the grant. The final reports and accounts shall be submitted on or before 31 Jan, 2021 through the Head of the Institution.

Principal Investigators to submit year wise measurable outcome of the proposal. This should be submitted before the release of installment without which grant will not be released.

Principal Investigators should publish at least one research paper in index journal (Indian citation index for social science, humanity & commerce, management science faculty, Scopus citation index for science faculty) by the end of 1st year, and submit one copy of the report in the Hon'ble Pro-Vice chancellor office & one copy in Plan & Stat section, failure of which the project will be suspended & grant will not be released. The PI will be called for presentation of the research project in front of the respective experts of the subject by the end of 1st year.

I am therefore requesting you to go through the rules (Copy enclosed) and according to Rule (6) give further undertaking in the enclosed form. On receipt of the same the first installment of grant will be released.
