2. Asset acquired wholly or partially out of sanctioned grant shall not be disposed or encumbered or utilized for the purposes other than those for which the grant was given without prior permission of Dr. Babasaheb Ambedkar Marathwada University, Aurangabad.
3. A register of asset acquired wholly or partially shall be maintained by principal investigator.
4. The head of Department shall ensure the utilization of the sanctioned grant for which it is being sanctioned / paid.
5. Principal investigator shall submit the six monthly progress report to under signed and present the said progress report in front of expert committee duly assigned by the university authority.
6. Failing to submission of two consecutive progress reports and or its presentation in front of expert committee shall be liable to cancellation or suspension of the sanctioned project.
7. Principal investigator shall publish two research publications in UGC-CARE list journals / Scopus indexed journals/ having Thompson Reuter impact factor. PI should acknowledge the financial support received from the university.
8. On the completion of the project ONE copy of consolidated report of the work done on the subject would be submitted to the RDC and Library of the university.
9. The PI would furnish to the University a utilization certificate, a audited statement of expenditure duly signed by PI, Finance and Account officer of the university pertaining to the grant at the end of each financial year as well as a consolidated statement of expenditure at the end of the completion of the project.
10. Dr.B.A. Marathwada University reserves the right to terminate the grant at any stage and also to recover the amounts already paid if itis convinced that the grant has not been properly utilized or the work on the project has been suspended for any unduly long period or appropriate progress is not being made.
