The Federal State Autonomous Educational Institution of Higher Education "Southern Federal University" (SFedU), (hereinafter - "Party 1"), represented by director of the Institute of Radio Engineering Systems and Control Anton Sergeevich Boldyrev, acting under a power of attorney № 218.02-07/07 issued on 09/01/2019, and Professor Dr. Ratnadeep R. Deshmukh, Department of Computer Science and Information Technology, Dr. Babasaheb Ambedkar Marathwada University, India (hereinafter - "Party 2"), acting on its own behalf, together referred to as the "Parties", hereby agree as follows:

1. Subject of the Agreement

- 1.1. Party 2 undertakes to provide to Party 1, free of charge, on the territory of Russia, Taganrog, in the buildings of Party 1, and in the distant form, the following educational services: delivering lectures as part of the state-accredited educational program of higher education in the scientific area of computer science and engineering.
- 1.2. The Services are provided in the amount of 42 hours per year for 3 and 4-year bachelor students and 1 and 2-year master students of SFedU Institute of Radio Engineering Systems and Control.
- 1.3. To deliver the Services the parties use the regular mode along with distance mode via the Internet, telephone and other means of communication. All relevant documents exchanged between the parties by means of electronic communication (e-mail) are recognized as valid and legally binding.
- 1.4. The Term of Services delivery is set from D1 November 2019 to 31 December 2022.

2. Rights and Obligations of the Parties

2.1. Party 2 is obliged to:

- 2.1.1. Independently provide themselves with the equipment needed for high-quality services described in Article 1 of this agreement: computer, internet connection, telephone.
- 2.1.2. Promptly notify Party 1 of any circumstances which may affect the quality and timing of Services delivery.
- 2.1.3. Provide the Services personally.

2.2. Party 1 is obliged to:

2.2.1. Provide Party 2 with the possibility to deliver the Services.

2.3. Side 2 has the right to:

2.3.1. Withdraw from the agreement, by issuing to Party 1 a written notice at least 7 days in advance.

2.4. Side 1 has the right to:

- 2.4.1. At any time, to check the progress and quality of the Services provided by Party 2, without interfering in its activities.
- 2.4.2. Terminate the contract.

3. Remuneration

3.1. This contract is a gratuitous, whereby there is no fee for the Services provided hereunder.

4. Final provisions

- 4.1. Disputes and disagreements arising between the parties concerning the fulfillment of their obligations under this Agreement shall be resolved through negotiations on the basis of current Russian legislation.
- 4.2. All changes and additions to this agreement shall be valid if set out in writing and signed by both parties.
- 4.3. This Agreement is written in two languages: English and Russian, having equal legal force, in two copies, one for each party.
