



Cultural, Scientific and Pedagogical Agreement between Università Degli Studi Del Sannio - Benevento, Italy and the Dr. Babasaheb Ambedkar Marathwada University, Aurangabad, 431004, INDIA

The Università Degli Studi Del Sannio, Benevento, Italy, aforementioned as University of Sannio, located at Benevento, Italy, represented by its Rector, Professor Filippo De Rossi and the Dr. Babasaheb Ambedkar Marathwada University, Aurangabad India, aforementioned as DBAM University, represented by its Vice-Chancellor, Professor B. A. Chopade.

DECLARE THAT

- Both institutions are interested in supporting science and culture development;
- In order to encourage the economic and social growth of populations, it is crucial to establish cooperation within the areas of science and culture;
- In order to pursue their aims and proposals, they need to establish communication channels to promote exchange activities;
- For these reasons both institutions consider very important the increasing of their relationships for academic and scientific cooperation and especially in the framework of research doctorate courses;
- The international cooperation has a high importance among the aims of both institutions.

For such purpose they have decided to seal an academic, scientific and cultural agreement by subscribing the following clauses:

**Clause One**

The present convention establishes the general principles and conditions under which both institutions intend to collaborate. The objectives of the present convention are the promotion of the development and spreading of culture and especially, the development of higher education at graduate and postgraduate level and scientific and technological research.

**Clause Two**

To fulfil the indicated objectives, both parts, by mutual agreement, will carry out cooperation programmes and projects by means of specific agreements.

### Clause Three

The Specific agreements to the present convention will cover the following aspects:

- Exchange of training staff, researchers and students;
- Training of teaching staff and researchers;
- Exchange of information and documentation;
- Graduate and post graduate courses;
- Seminars, conferences, discussions, meetings, sessions, etc.
- Publications and scientific projects.

### Clause Four

The specific agreements appended to the present convention shall be approved by the Governing Body of both institutions and signed by their legal representatives. No exchange programme and/or cooperation project shall be carried out without being, previously defined and regulated in a specific agreement.

### Clause Five

The present convention will take effect from the day of signing, and will remain in force for **Five** years, being automatically renewed for successive **Five** year periods, unless it is cancelled by mutual agreement or by any of the parties, upon written notice given **Six** months prior to the date of termination. The termination of the present convention will not affect the programmes and projects established in specific agreements until they are finished.
