MEMORANDUM OF UNDERSTANDING BETWEEN

THE Dr. BABASAHEB AMBEDKAR MARATHWADA UNIVERSITY (India)
AND

THE UNIVERSITY OF SRI JAYEWARDENEPURA (Sri Lanka)

The Dr. Babasaheb Ambedkar Marathwada University of India and the University of Sri Jayewardenepura of Sri Lanka hereby agree to establish a formal linkage that will develop further co-operation and exchange in wider areas of interest. In pursuit of this objective, we have agreed as follows.

To develop a split Ph.D. programme for the Management and Commerce subject area of the University of Sri Jayewardenepura.

To assist the University of Sri Jayewardenepura to develop a masters Degree programme in Accountancy.

To make arrangement for the lectures of the Faculty of Management Studies and Commerce to pursue studies under the Ph.D. programme of the Dr. B.A. Marathwada University as residential or non-residential students.

To exchange services of academic and research staff between the two Universities.

To develop research interest of mutual benefit and to undertake joint research projects.

To organize international symposia and conferences.

To exchange students between the two Universities.

The Memorandum of Understanding (MOU) will come into effect upon the date of signing and will remain in force for a period of five years from the date of signing. The MOU shall be automatically extended for successive periods of five years each, unless either party notifies the other in writing six months prior to the expiration of each period of its intention to terminate the agreement.

Professor G.A. Nikam and Dr. M.W. Wickramarachchi will be appointed as first coordinators of the programme.
