Whereas Department of CS & IT-Centre known for its valuable contribution in the field of Computer Science and Information Technology at National and International Level like Speech Processing, Pattern Recognition, Image Processing & Analysis, Artificial Intelligence, Computer Networking, Human-Computer Interfacing, Software Engineering and Testing, Biometrics and Security and application through the involvement of the stake holders (students, faculties, individual and entrepreneurs) and is willing to utilize the premises of MIT, for its training and MIT has agreed to offer its facilities for the same as per the terms and conditions mentioned

- MIT will offer classroom/s with all infrastructure including an internet connected computer, projector, seating for at-least 30 students and lab area for 30 students as well as any infrastructure needed for the advanced IT courses training.
- MIT and Department of CS & IT, Dr. BAMU shall make provisions to share their respective important R&D facilities in order to promote academic and research interaction in the areas of cooperation through practical training and in addition to this Faculty and Students exchange program for prolonged duration which may lead for filing of patents of some good research work.
- MIT and Department of CS & IT, Dr. BAMU shall make provisions to share the facilities of the Department laboratories in Signal & Image Processing, HMI, and Multimodal etc.
- Both MIT and Department of CS & IT, Dr. BAMU will be free to independently carry out follow-up research on the thesis work conducted under this scheme.
- Any clause or article of the MOU may be modified or amended by mutual agreement of Department of CS & IT, Dr. BAMU and MIT.

TERMS AND TERMINATION:

This MOU unless extended by mutual written agreement of the parties, shall expire in three years after the effective date specified in the opening paragraph. This MOU may be amended earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU with 60 days prior written notice to other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any research agreement or any other agreement entered into.
