



Memorandum of Understanding

This agreement made between Dr. Babasaheb Ambedkar Marathwada University, Aurangabad, hereafter called as University and Endress+Hauser (India) Automation Instrumentation Pvt. Ltd. & Endress+Hauser Flowtec (India) Pvt. Ltd. The validity of this agreement will be for 2 years and would be revised upon mutual agreement by University and Endress+Hauser., hereafter called as E+H on **23rd Day of September 2018**, is as per the terms listed below:

1. E+H will sponsor 10+10 (First + Second year) =20 Scholarships @ Rs.25000 per PG Student per annum for 2 years course. The Students will be selected from
 - a. Government Engineering college (Mech./Elec./Electronics Branches)
 - b. Department of Physics (M.Sc. Electronics)Y
 - c. Department of Computer Science (M.Sc./M.Tech.)
 - d. Department of Chemical Technology

Preferably there should be equal number of boys and girls and from economically backward section.

C. DDUK (UNIVERSITY CAMPUS) N.W. D.V.

These students are encouraged to work on Projects jointly decided/conceived by University and Endress+Hauser.

Selection of the students for Scholarship will be done jointly by University/Endress+Hauser Committee under Chairmanship of Hon'ble Vice-Chancellor or his nominee.

2. Endress+Hauser Engineers will give invited Lectures at University Campus on Saturdays. These Lecture Sessions will be on Soft Skills, Value Added Courses/Subjects.
3. One week crash course in Measurement Instrumentation & Process Automation would be done by Experts of E+H for in Measurement Instrumentation & Process Automation.

Endress+Hauser will provide German to English Translation of course material for one week training Programme on Instrument Automation.

Memorandum of Understanding between Aurangabad Electricals Ltd and Dr Baba Saheb Ambedkar Marathwada University, Aurangabad

This Memorandum of Understanding (MoU) is made at Aurangabad this 16th day of March 2012 between Aurangabad Electricals Ltd ("AEL") and Dr Baba Saheb Ambedkar Marathwada University ("BAMU"), Aurangabad to record the basic understanding of the scholarship proposed to be given to students of BAMU.

1. Name of scholarship:

The scholarship will be named as LATE R N BAGLA SCHOLARSHIP.

2. Eligibility for scholarship:

The scholarship will be given to selected students doing post graduate studies in electrical or mechanical engineering in any of the affiliated engineering colleges of BAMU. Four students will be selected for this purpose every year by BAMU at its own discretion based on merit and need. A student whose annual family income from all sources is below Rs.2 lacs will be considered. Any student involved in criminal or riotous activities will not be eligible for scholarship. Decision taken by BAMU in this regard will be final.

3. Amount of scholarship:

Amount of scholarship per student will be Rs.25,000/- per year for a period of two years. However, scholarship will be given for second year only in case the student successfully completes requirement of first year examination.

4. Mode of payment:

Scholarship will be sponsored by AEL and hence AEL will make available a total amount of Rs.1 lac to BAMU for first year (@ Rs.25,000 per student for 4 students) and Rs.2 lacs from second year onwards. BAMU will select eligible students and will give cheques to the students directly. In case any student unfortunately fails in the first year examination and the amount remains unspent in second year, any decision in respect of such an amount unspent balance will be taken by BAMU in consultation with AEL.

5. Termination:

AEL will have a right to terminate this arrangement at any time by giving one month notice to BAMU.
