Sub: Establishment of Institutional Animal Ethics Committee (IAEC)

Dr. Babasaheb Ambedkar Marathwada University proposed to establish animal house in the new building of Paul Hebert Centre for DNA Barcoding and Biodiversity Studies. In this regards a detailed project proposal was prepared by Dr. GD Khedkar and submitted to the district collector, Aurangabad through the registrar of the university (Flag A).

The administrative approval for said proposal was accorded by the Hon'ble District Collector, Aurangabad (Flag B).

The proposed animal house will be established for breeding and experimentation purpose for small animals like mice, genie pig, rabbit, drosophila, zebra fish, etc.

For starting animal house facility, first step will be establishment of Institutional Animal Ethics Committee (IAEC). The composition suggested by Government of India, Ministry of Environment, Forest and Climate Change, Animal Welfare Division, Committee for the Purpose of Control and Supervision of Experiments on Animal (CPCSEA) vide letter no F. No. 25/4/2017-CPR/SLA dated March 8th, 2018 is as below:

The composition of IAEC should be as under (Flag C):

- i. A Biological Scientist
- ii. Two Scientists from different biological disciplines
- iii. A Veterinarian involved in the care of Animals (Mandatory)
- iv. Scientist In-Charge of Animal House Facility
