3. RUSA proposal was placed before departmental committee for discussion, it was resolved to forward the proposal to university.


The following points were discussed under AOB.

1. Departmental committee congratulates Pravin Yannawar (PI) and Dr. Milind Sardesai (Co-PI) for Interdisciplinary research project grant of Rs. 3.80 Lakhs from Additional Principal Chief Conservator of Forest and Silviculturist, Van Bhavan Pune. The following points were also been discussed and resolved in light of project requirements
 - a. Regarding purchase of equipment's sanctioned under project sanction to Dr. Pravin Yannawar, it was resolved to purchase LAPTOP's, Multi-Function Printer by calling quotations from the vendors or by following university rate contract. PI has to complete the process as per university norms.
 - b. 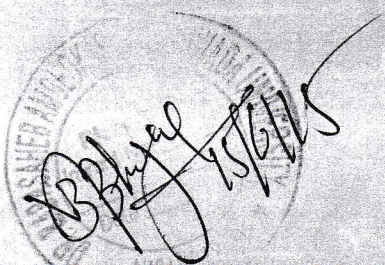
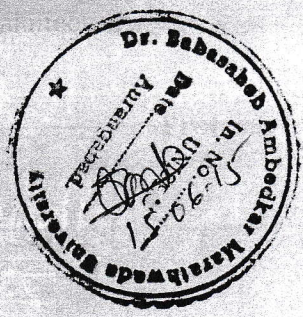
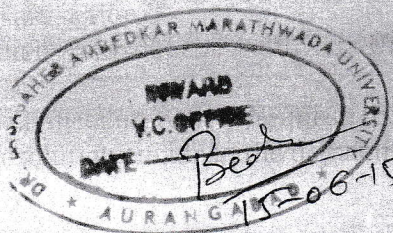
