Resolution - 8 : AOB :-


1: Administrative Approval for remaining instruments from Non-recurring Budget :-

It is resolved that, purchase the remaining instruments (Attached Separate list) (Annexure-I) for non recurring budget.


2: MoU with Clean Air Asia, India :-


