With reference to your application dated 10-12-2009 for the post of Assistant Professor in the subject of Mathematics and further to the interview you had with us on 09-05-2010, you have been appointed as Assistant Professor (UGC XIth Plan Post) on purely temporary and on contract basis upto 31-03-2012 (vide letter under reference).

The Government of Maharashtra vide G. R. No. AMU 2007/(165/07)-vishi-1, dated 30-03-2012 conveyed that the Government of Maharashtra has taken over the liability of the teaching posts sanctioned by the University Grants Commission under the XIth Five Year Plan w.e.f. 01-04-2012.

I am directed to inform you that, the Hon'ble Vice-Chancellor, in exercise of the powers, conferred upon him under Section 14 (9) of the Maharashtra Universities Act, 1994, is pleased to appoint you on the **substantive post of Assistant Professor** in the subject of **Mathematics** in the Department of **Mathematics** in the pay band of **Rs. 15600-39100 (AGP Rs. 6000/-) (Revised)** plus other allowances admissible under the existing rules and as may be revised from time to time, by the Government / UGC on the following terms and conditions.

- 1] Your appointment is for **Other Backward Class Category** on Probation for a period of One Year from 01-04-2012.
- 2] You will receive allowances as per prevailing rules.
- 3] Your services will be governed by the Maharashtra Universities Act, 1994, Statutes, Ordinances, Regulations, Rules made there under for the time being in force and as may be amended or modified from time to time. Orders of the competent authorities issued from time to time shall also be binding on you.
- 4] If applicable, Newly Government introduced **Defined Contribution Pension Scheme** will be made applicable to you.
