With reference to your application dated 16-01-2009 for the post of **Lecturer** in the Department of **Chemistry (Sub-Centre) Osmanabad** and further to the interview you had with us on 11-08-2009, I am directed to inform you that the Hon'ble Vice-Chancellor, in exercise of the powers, conferred upon him under Section 14(9) of the Maharashtra Universities Act, 1994, is pleased to appoint you as **Lecturer** in the subject of Chemistry in the Department of **Chemistry (Sub-Centre) Osmanabad** in the pay scale of **Rs. 8000-275-13500** plus other allowances admissible under the existing rules and as may be revised from time to time, by the Government on the following terms and conditions.

- 1] Your appointment is for the post reserved for **Scheduled Caste Category**.
- 2] Your appointment on the said post is purely on a temporary on contract basis for a period of five years from the date of joining as this post is created through University Fund. You will not be entitled to receive any other permanency benefits which are applicable & available to the permanent teachers.
- 3] Your services shall be governed by the Maharashtra Universities Act, 1994, in force for the time being and that may be amended from time to time, and the Statutes, Ordinances, the Rules and Regulations made there under and, in force for the time being and that may be amended from time to time,
- 4] The terms and conditions of your appointment as a **Lecturer in Chemistry (Sub-Centre) Osmanabad** shall be subject to the directions, orders, instructions etc. that may be issued/ given by the Maharashtra State Government and U.G.C., from time to time, and the service contract shall stand modified/ altered to that extent accordingly,
- 5] Your services shall come to an end automatically, if the antecedent report from the police authority is not found satisfactory.

- 6] You will have to undergo a medical test at the University Health Centre. If the medical report from the Medical Officer of the Health Centre of the University is not found satisfactory, your appointment shall come to an end automatically.
- 7] At the time of joining the duties you will have to submit attested xerox copies of all the testimonials for record of the office and will have to produce original testimonials for verification.
- 8] You will also enter into the service contract with the University that shall govern the terms and conditions and the university may prescribe conditions of your service inclusive of above mentioned conditions and such other conditions, in this regard.

If these terms and conditions are acceptable to you, you are requested to communicate your acceptance to the University in the format enclosed herewith and report for duty to the Director, Dr. Babasaheb Ambedkar Marathwada University, Sub-Centre, Osmanabad within a period of one month from the date of receipt of this appointment order.
