- 4] The terms and conditions of your appointment as a Lecturer in Physical Education shall be subject to the directions, orders, instructions etc. that may be issued/given by the Maharashtra State Government and U.G.C., from time to time, and the service contract shall stand modified/altered to that extent accordingly,
- 5] Your services shall come to an end automatically, if the antecedent report from the police authority is not found satisfactory.
