Statement of Scholarship Acceptance

I, Vandana Hivrale, selected within the framework of the Merging Voices Project ("Erasmus + Programme – KA107- International Credit Mobility") to undertake a "Administrative Staff" mobility at Universidade do Algarve, Portugal, declare:

- **For students:** To have not benefited in the past from an Erasmus Mundus or Erasmus+ scholarship for more than 6 months for the same type of mobility in the same cycle of study;
- **For undergraduate students:** to be registered in an institution of the Consortium; to have completed his first year by the time the mobility starts; to be eligible for a credit mobility in the next academic year; to have guaranteed full academic recognition of study results obtained abroad;
- **For Master and PhD candidates:** to be registered in an institution of the Consortium, to be eligible for a credit mobility in the next academic year and to have guaranteed full academic recognition of study results obtained abroad;
- **For staff:** to have a formal link to an institution of the Consortium;
- To acknowledge and accept all conditions set in the Scholarship Contract regarding the participation in this Project, namely the following:
 1. The coordinating institution has the right to suspend the payment of the scholarship, without no right to any type of compensation for damages, if:
 - i. the scholarship holder withdraws from the project;
 - ii. the scholarship holder does not comply with the internal regulations of the host institution/the Merging Voices consortium or with the academic quality standards of the Project;
 - iii. there is evidence of bad conduct or of other security-related issues.
 2. The coordinating institution has the right to demand the partial or total reimbursement of the awarded mobility grant (monthly scholarship, travelling costs, insurance) if:
 - i. The scholarship holder withdraws from the project without a reason considered by the Coordination as *force majeure*;
 - ii. the scholarship holder does not comply with the internal regulations of the host institution/the Merging Voices consortium or with the academic quality standards of the Project;
 - iii. there is evidence of bad conduct or of other security-related issues;
 - iv. the scholarship holder was selected based on previous false declarations, which led to the misidentification of her/his eligibility to participate in the Project.

The coordinating institution will determine the amount of the reimbursement.
 3. In case of reimbursing obligation, the scholarship holder has 30 days after the notification received from the Coordinating Institution to proceed with the reimbursement via bank transfer. The Coordinating Institution will provide specific instructions to the scholarship holder on reimbursement procedures. If the scholarship holder fails to do so, additional banking fees and interests will be charged and judicial steps will be taken.
 4. Scholarship holders may not accept, during the period of the current Merging Voices grant, any other mobility grant awarded by the European Union.
 5. The scholarship holder commits her/himself to return to her/his home country at the end of the scholarship period.
 6. The scholarship holder formally agrees that his/her personal data may be used for benefit of this Project or future ones within the framework of the Erasmus+ Programme.
