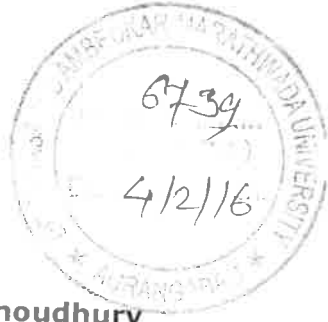

1. During the tenure of fellowship **Dr. Sandhya Mohitya Govind** will be entitled to the following:
2. The amount of fellowship and contingency grant will be as under:

i.) Fellowship amount @ Rs.28,000/- p.m. x 12.	For One Year
ii.) Contingency grant @ Rs.20,000/- p.a	Rs.3,36,000/-

The Sanctioned grant will be released in three installments as follows:

1. First Installment	Rs.1,78,000/- (6 Months Fellowship + 50% Contingency)
2. Second Installment	Rs.1,20,000/- (4 Months Fellowship + 40% Contingency)
3. Third Installment	Rs. 58,000/- (2 Months Fellowship + 10% Contingency)
Total	<u>Rs.3,56,000/-</u>

3. The First installment of **Rs.1,78,000/-** will be released of receipt of the enclosed grant-in-aid bill duly signed on a revenue stamp may be furnished immediately on receipt of the statement.
4. The Second installment of **Rs.1,20,000/-** will be released on receipt of the detailed six monthly progress report (**Format Enclosed**) and a statement of expenditure in respect of the first six months of the fellowship.

5. The final installment of **Rs.58,000/-** will be released on receipt of a complete and satisfactory report and a statement of total expenditure incurred on the fellowship. This should be followed by an audited statement of account and utilization certificate duly signed by the statutory auditors.
6. All the fellowships are subject to income tax deductions, which shall be made by the affiliating institution.
7. Unless the ICSSR decides otherwise, all equipment purchase out of the contingency grant should be transferred to the affiliating institutions, which shall certify that it has taken them on its stock register.
8. The fellows must submit three hard and one soft copies of the final report on the work done by him/her as fellow of the Council, in a publishable form along with an abstract of the report within six months after the completion of the fellowship. **This report will be evaluated by an independent subject expert appointed by the ICSSR.**
9. In case the report is plagiarized, not received within the stipulated period or modified as suggested of our expert, the fellow will be debarred from any financial support under any scheme of the Council including support for visits abroad either as individual scholar or as member a delegation. He/She will also not be associated with any committee/programme that the Council may set up/organize from time to time.
10. **The amount of grant sanctioned herein is to be utilized by stipulated period. Any amount of the grant remaining unspent during the period shall be refunded to the ICSSR immediately after completion of the project. If the grantee fails to utilize the grant for the purpose for which the same has been sanctioned, the grantee will be required to refund the amount of the grant with interest thereon @10% per annum from the date of its sanction.**
