Subject: Award of Senior Academic Fellowship of ICHR for the year 2013-14.

Dear Sir/Madam,

With reference to your application for the award of the ICHR's Senior Academic Fellowship (SAF). I am glad to inform you that the 136th Research Projects Committee (RPC) of the Council has awarded you SAF to work on *Identification and Classification of Textiles, Costumes, Ornaments and Coiffure in the Paintings and Sculptures of Ajanta and Aurangabad Cave Temples*. **The amount of this Fellowship shall be Rs.40, 000/- per month along with a Contingency Grant of Rs.40, 000/- per annum.**

2. This award of fellowship will be subject to the following **terms and conditions**:

- The term of fellowship is for a period of two years only from the date of its acceptance.
- During the course of this fellowship which is on a whole-time basis, you will not accept any other fellowship or financial assistance or employment whether full-time or part-time from any other organization, Provided that you can continue with your previous employment, if you take leave during the period of this fellowship.
- The pay of the in-service scholars/ academics (Employed in Universities, Government Department, etc.) will be protected. In case of retired scholars/ academics pension will not be deducted from the amount of the fellowship.

- (d) The amount of fellowship will be directly credited to your bank account electronically for which you have to submit the details to the Council in the enclosed format.**
- (e) You will submit a six-monthly report in triplicate to the institution of affiliation for being forwarded to the ICHR for getting it evaluated by the subject expert. Along with this report you will also submit a statement of accounts of the expenditure done out of the contingent grant with the relevant bills/vouchers in original.
- (f) Further installment(s) of fellowship will not be released, if the progress report(s) for the period for which the payment has been made are not furnished, or, if furnished, are not found satisfactory.
- (g) At the end of the year you would submit an annual comprehensive report which would be evaluated for continuation of the fellowship to the second year.
- (h) The amount of fellowship and of the contingency grant for the last six months will be withheld. This will be released only after the satisfactory completion of the research work and on submission to the ICHR of a complete publishable copy of the research work done and the conclusions reached by you, indicating the due acknowledgement to the ICHR's grant and other material.
- (i) Should you after joining the fellowship, cease to work on the project for a time either because of ill-health or your obtaining other gainful employment or for some other reason, you shall have to apply for leave to the ICHR, and should such leave be granted by the Chairman, which shall not exceed six months during the entire tenure of Fellowship, the period (s) of said leave shall be counted towards determining the duration of the fellowship. During the period of your absence whether on leave or otherwise, you will not draw fellowship and contingency grant.
- (j) You will not be eligible for another fellowship from the ICHR for the next five years from the date of acceptance of this fellowship.
- (k) Should you decide to discontinue the fellowship without completing the Research work, you shall be liable to refund the entire amount of fellowship alongwith contingency grant received for the purpose.
- (l) This award of fellowship will lapse without any notice, if you fail to avail of it within three months from the date of meeting in which the proposal was approved.

(m) This fellowship will further remain subject to the compliance with all other relevant provisions concerning the award of Fellowship in the Research Funding Rules of the ICHR.

3. You are requested to convey your acceptance to the award of the above said fellowship along with an Undertaking in the enclosed format duly filled in and signed and clearly dated on a stamp-paper of ten rupees, and also indicate the date from which you will start your work. **Your acceptance to the award of this fellowship must reach to the ICHR within fifteen days from the date of its receipt.**

Dear Shri Ghadge Gautam,

With reference to your application for the award of ICHR's Junior Research Fellowship (JRF) I am glad to inform you that the Junior Research Fellowship Committee of the Council has awarded you JRF to work on "*Analysis of Historical Situation of Farmers after Independence Period with Special Reference to Beed District (1950-2010 A D)*". The amount of the fellowship shall be ₹ 16,000/- per month along with a contingency grant of ₹ 15,000/- per annum.

2. **This award of fellowship will be subject to the following terms and conditions:**

- The term of fellowship is for a period of two years only.
- During the course of this fellowship which is on a whole time basis you will not accept any other fellowship or financial assistance or employment whether full-time or part-time from any other organization. However, you can continue with your previous employment, if any, if you take leave during the period of this fellowship.
- The fellowship shall automatically terminate two months after the fellow submits his Ph.D thesis or on the date of his viva voce examination on the said thesis whichever is earlier. It shall also automatically terminate upon the fellow ceasing to be eligible to submit the said dissertation or thesis at the University where he is registered.
- The amount of fellowship will be directly credited to your bank account electronically for which you submit the details to this Council in the enclosed format**
- You shall submit a six-monthly report in triplicate to the University of Affiliation for being forwarded to the ICHR. The report shall be duly certified by the Supervisor, and in case he is unavailable, by the Head of the Department in which you are working. Along with this report you will also submit a statement of accounts of the expenditure done out of the contingency grant and the relevant bills/vouchers in original duly processed by the concerned authority of your University (Registrar/Finance Officer/Principal).
- Further installments of fellowships shall not be released if the progress report for the periods for which the payment has been made are not furnished, or, if furnished, are not found satisfactory.
- At the end of the year you would submit an annual comprehensive report which would be evaluated for continuation of the fellowship to the second year.
- The amount of the fellowship and of the contingency grant for the last six months will be withheld. This will be released only after the satisfactory completion of the research work and submission to the ICHR of a complete publishable copy of the research work done and the conclusions reached by you, indicating the due acknowledgement to the ICHR's grants and other material.

- (i) Should you after joining the fellowship, cease to work on the project for a time either because of ill-health or your obtaining other gainful employment or for some other reason, you shall have to apply for leave to the ICHR and should such leave be granted by the Chairman, which shall not exceed six months during the entire tenure of Fellowship, the period (s) of said leave shall be counted towards determining the duration of the fellowship. During the period of your absence whether on leave or otherwise, you will not draw fellowship and contingency grant.
- (j) You will not hold any fellowship from the ICHR in a span of five years (whether preceding or succeeding) from the date of acceptance of this fellowship.
- (k) Should you decide to discontinue the fellowship without completing the Research work, you shall be liable to refund the entire amount of fellowship plus contingency grant received for the purpose. The continuation of the fellowship is contingent upon your good conduct and may stand terminated if adverse report about your conduct is received from the University or institution where you are enrolled.
- (l) This award of fellowship will lapse without any notice, if you fail to avail of it within three months from the date of meeting in which the proposal was approved.
- (m) This fellowship will further remain subject to the compliance with all other relevant provisions concerning the award of Fellowships in the Research Funding Rules of the ICHR.

3. You are requested to intimate your acceptance of the ICHR's Junior Research Fellowship along with: (a) date of joining of fellowship and (b) Undertaking in the prescribed format (enclosed) on a non-judicial stamp paper of Rupees Ten only within a month of the present communication.
