

With reference to your application for the award of ICHR's Junior Research Fellowship (JRF) I am glad to inform you that the 148<sup>th</sup> meeting of the Research Projects Committee held on 21/03/2017 have awarded you JRF to work on "Swatantryottar Bharatatil Jamatwadacha Vikas-1947 Te 2002 (Development Of Communalism In Post Independent India A.D.1947 -A.D.2002)". The amount of the fellowship shall be Rs.17,600/- per month along with a contingency grant of Rs.16,500/- per annum.

### This award of fellowship will be subject to the following terms and conditions:

1. The term of the fellowship is for a period of two years only.

2. This fellowship shall be a whole-time engagement for research work and cannot be combined with any other whole-time or part-time work.

Provided that—

- A Fellow can continue with his previous employment, if she/he takes leave during the period of the Fellowship; and
- A part-time honorary or nominally paid teaching or research assignment may be accepted by a Fellow with the permission of the Research Projects Committee.
- 3. The fellowship shall automatically terminate two months after the fellow submits her/his Ph.D thesis or on the date of his viva-voce examination on the said thesis whichever is earlier. It shall also automatically terminate upon the fellow ceasing to be eligible to submit the said dissertation or thesis at the University where he is registered.
- 4. The amount of fellowship will be directly credited to your bank account electronically for which you shall submit the details to this Council in the enclosed format
- The pay of in-service scholars employed in Universities, Government Departments etc. may be protected by the parent institution and in case of retired scholars/academics pension will not be deducted from the amount of the Fellowship granted by the Council. It is clarified that the pay protection to in-service scholars will not be given by the Council. The concerned college/University/Institution should forward only such application(s) when they consent to protect the salary of the scholar(s) and allow him to avail of the ICHR's Junior Research Fellowship.

You shall submit a six-monthly report in triplicate to the University of Affiliation for being forwarded to the ICHR. The report shall be duly certified by the Supervisor, and in case she/he is unavailable, by the Head of the Department in which you are working. Along with this report you will also submit a statement of accounts of the expenditure incurred on account of contingencies and the relevant bills/vouchers in original duly processed by the concerned authority of your University (Supervisor & HOD).

Further installments of fellowships shall not be released if the progress report for the periods for which the payment has been made are not furnished, or, if furnished, are not found satisfactory.

for continuation of the fellowship in the second year.

9. In case of all the Fellowships, the amount of Fellowship and of the contingency grant for the last three months will be withheld. This will be released only after the submission to the ICHR a publishable manuscript based on the research done during the fellowship. When the manuscript is published, due acknowledgment should be made to the Fellowship of the ICHR.

10. Should you after joining the fellowship, cease to work on the project for a time either because of ill-health or your obtaining other gainful employment or for some other reason, you shall have to apply for leave to the ICHR and should such leave be granted by the Chairperson, which shall not exceed six months during the entire tenure of Fellowship, the period (s) of said leave shall be counted towards determining the duration of the fellowship. During the period of your absence whether on leave or otherwise, you will not draw the fellowship and contingency grant.

11. Should you decide to discontinue the fellowship without completing the Research work, you shall be liable to refund the entire amount of fellowship plus contingency grant received for the purpose. The continuation of the fellowship is contingent upon your good conduct and may stand terminated if adverse report about your conduct is received from the University or institution

where you are enrolled.
