ORDER

**Subject:** Financial assistance for research project under FAST TRACK SCHEME FOR YOUNG SCIENTIST entitled "**Analysis of visual speech using multiple camera angles for audio visual speech recognition**" by Dr. Pravin L Yannawar, Assistant Professor, Department of Computer Science & Information Technology, Dr. Babasaheb Ambedkar Marathwada University, , Aurangabad-431004, Maharashtra –Release of 1<sup>st</sup> installment.

Sanction of the SERB is hereby accorded to the above mentioned project at a total cost of Rs. 17,62,000/- (Rupees seventeen lakhs sixty two thousand only) with the break-up of Rs. 6,98,000/- under Capital head and Rs. 10,64,000/- under General head for a duration of 3 years. The items of expenditure for which the total allocation of Rs. 17,62,000/- has been approved for 3 years are given as below :-

- Overhead expenses are meant for the host Institute towards the cost for providing infrastructural facilities and benefits to the staff employed in the project, etc.
- Sanction of the SERB is also accorded to the payment of Rs. 10,50,000/- (Rupees ten lakhs fifty thousand only) with the break-up of Rs. 6,98,000/- (Rupees six lakhs ninety eight thousand only) under head 'Grants for creation of capital assets' (46.01.35) and Rs. 3,52,000/- (Rupees three lakhs fifty two thousand only) under head 'Grants-in-aid General (46.01.31)' to the Registrar, Dr. Babasaheb Ambedkar Marathwada University, , Aurangabad-431004, Maharashtra being the first installment of grant for the year 2013-14 for implementation of the above said project.
- Sanction of the grant is subject to the conditions as detailed in Annexure-I.
- The amount of Rs. 10,50,000/- (Rupees ten lakhs fifty thousand only) will be drawn by the Drawing and Disbursing Officer, SERB and will be disbursed to the Registrar, Dr. Babasaheb Ambedkar Marathwada University, , Aurangabad-431004, Maharashtra by means of an A/C payee cheque.
- The Institute will furnish to the SERB Utilization Certificate (U/C) and audited Statement of Expenditure pertaining to the grant immediately after the end of each financial year.
- All purchases of equipments etc. would be as per GFR and the disposal of the same would be done with prior approval of SERB.
- As per Rule 211 GFRs the accounts of the project shall be open to inspection by the sanctioning authority / audit whenever the Institute is called upon to do so.

9. The institute will maintain separate audited accounts for the project. If it is found expedient to keep a part or whole of the grant in a bank account earning interest, the interest earned should be reported to the SERB. The interest thus earned will be treated as a credit to the Institute to be adjusted towards further installment of the grant.
10. The Sanction has been issued with the approval of the competent authority under delegated powers and vide sanction number **SERB/F/ 1766 /2013-2014** dated **21/06/2013**.
