3. The Grants is subject to the adjustment of the basis of Utilization Certificate in the prescribed performa submitted by the University/Colleges institution. 4.

The University College shall maintain proper accounts of the expenditure out of the grants which shall be

utilized only on approved items of expenditure.

The University/College/Institution may follow the General Finanacial Rules, 2005 and take Urgent necessary 5. action to amend their manuals of financial procedures to bring them in conformity with GFRs, 2005 und instructions/guideline there under from time to time. 6.

The Utilization Certificate of the effect that the grant has been utilized for the purpose for which it has been sanctioned shall be furnished to the University Grants Commission as carly as possible after the close of the

current financial year.

The assets acquired wholly or substantially out of University Grant Commission's grant shall not be disposed or 7. encumbered of utilized for the purposes other than those for which he grant was given, without proper sanctioned of the University Grants Commission and should, at any time the College University ceased in function such assets shall revert to the University Grant Commission. 8.

A Register of assets acquired wholly or substantially out of the grant shall be maintained by the

University/College in the prescribed form.

The grantee institution shall ensure the utilization of grant-in-aid for which it is being sanction/paid. In case 9. non-utilization/part utilization, the simple interest @ 10% per annum as amended from time to time on unutilized amount from the date of drawl to the date of refund as per provisions contained in General Financial Rules of Govt, of India will be charged.

The University/College/Institute shall follow strictly the Government of India University Grants Commission 10. guidelines regarding implementation of the reservation policy (both vertical (for SC,St & OBC) and

horizontal (for persons with disability etc.)} in teaching and non-teaching posts.

The University/College shall fully implement to Official Language Polici of Union Govic and comply with the 11. Official Language Act, 1963 and Official Languages (Use for Official purposes of the Union) Rules, 1976 etc. 12
