

AGREEMENT ON ACADEMIC COOPERATION  
BETWEEN  
THE FACULTY OF SCIENCE,  
DR. BABASAHEB AMBEDKAR MARATHWADA UNIVERSITY  
AURANGABAD,INDIA  
AND  
THE FACULTY OF ENGINEERING,  
THE UNIVERSITY OF TOKUSHIMA

The Faculty of Science, Dr. Babasaheb Ambedkar Marathwada University, and the Faculty of Engineering, the Graduate School of Advanced Technology and Science and the Institute of Technology and Science, The University of Tokushima (hereafter, referred to as the Faculty of Engineering, The University of Tokushima) enter into this official agreement with the objective of promoting cooperation in the fields of academic research and education between the two universities on a basis of mutual and equal benefit.

Article 1

The Faculty of Science, Dr. Babasaheb Ambedkar Marathwada University, Aurangabad, India, and the Faculty of Engineering, The University of Tokushima agree to promote the following activities of mutual interest:

- (1) Conducting joint research projects
- (2) Exchange of academic information
- (3) Exchange of research staff members
- (4) Exchange of students

Article 2

For implementing the Agreement, financial and other arrangements shall be negotiated and determined separately for each case.

Article 3

Intellectual property rights, results and publications are to be managed as follows:

- (1) All materials, information and intellectual property that arise from the activities of Article 1 shall be freely available for research purposes to both of the universities.
- (2) Any commercial exploitation of the materials, information and intellectual property that arise from the activities of Article 1 shall be jointly undertaken by both of the two universities and be the subject of separate agreements.
- (3) The results that arise from the activities of Article 1 above cannot be used for purposes other than the maintenance of international peace and safety.
- (4) Publications within the framework of the activities under this Agreement shall be jointly undertaken by both of the universities.

Article 4

The Agreement takes effect from the date of signing for five years and continues its effect for five years unless either university states otherwise. Each university may terminate the Agreement at anytime by written notification of the termination by written notice at least six months in advance of the termination.

Article 5


Any modification to the Agreement shall be undertaken based on the mutual consent of both universities.

Article 6

The Agreement shall be written in English and Japanese and shall take effect when signed by the Registrar of Dr. Babasaheb Ambedkar Marathwada University, Aurangabad and the Dean of the Faculty of Engineering, The University of Tokushima. In the event of a dispute as to the terms and conditions of the English and Japanese versions, the parties agree that the English version shall be used.
