As recommended by the J&K Public Service Commission, sanction is hereby accorded to the appointment of **Mr. Bashir Ahmad Mir S/o Nazir Ahmad Mir R/o Ratnipora Pulwama**, figuring at S.No. 01 (OM), waiting list under direct quota, as Lecturer Physical Education in Youth Services and Sports Department in the pay scale of Rs. 9300-34800 with Grade pay of Rs. 4300/- and his posting in Government Higher Secondary School Dadsara, Pulwama against an available vacancy.

The appointee shall be on probation for a period of two years. He shall be allowed to join only on production of the following certificates/documents in original in the concerned Government Higher Secondary School within 21 days from the date of issue of this order failing which his appointment shall be deemed to have been cancelled:-

- i. Permanent Resident Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by the Competent Authority.
- iv. Academic and Technical Qualification Certificate.
- v. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self employment Scheme has been taken.
- vi. Category certificate, if any.

However, if on verification, the certificates/documents produced by the appointee are proved to be fake or forged, his appointment shall be cancelled abinitio.

The salary of the appointee shall be drawn and disbursed to him only on receipt of the verification report of his academic/technical qualification/category certificates and verification of his character and antecedents from the Additional Director General of Police, CID to whom a reference shall be made. In case the candidate is adversely reported upon by the verifying agency viz CID or the relevant category certificate is not found genuine/valid, he shall have no claim to hold the post to which appointed and his appointment shall stand automatically cancelled without any further notice.

The inter-se-seniority of the appointee shall be determined in accordance with the merit position assigned to him by the Public service Commission.
