



## Detailed evaluation report of the MRP, submitted to ICSSR by

Dr. Prashant B. Pagare

Title: "E-learning Based Training Programme for Professional Development of Teacher Educators in Backward Region of Marathwada."

I have gone through the research project titled "E-learning based training programme for professional development of teacher educators in backward region of Marathwada". This research project is divided into five chapters. Chapter one deals with introduction of the project. Chapter two outlines the related literature of the project where theoretical background of the work has been discussed in detail. The third chapter describes the methodology and tools employed for data collection. The fourth chapter is confined with the analysis and interpretation of the data. The fifth chapter deals with the summary and conclusions of the study. Following observations have been made.

- The conceptual framework of the present study is satisfactory.
- Objectives and hypotheses are scientifically formulated and well organized.
- From 80 B.Ed. colleges, 160 Teacher Educators were taken for the study with the help of purposive sampling.
- Statistical techniques employed for data analysis are appropriate.
- The t-test results confirmed that there were significant differences in favour of experimental group. It concludes that e-learning training helps teacher educators to improve their e-learning, knowledge and understanding in the context of teaching and planning. Recommendations and Educational implications of the study are based on the findings of the study.
- Literature of the thesis is quite satisfactory.
- On the basis of above observations I recommend that the present research project may be accepted by the ICSSR.
